- This program begins **December 1, 2025, and ends November 30, 2026**, or when funds are depleted, whichever comes first.
- Rebates are limited to **one per appliance type per address**.
- Rebates will only be paid for new purchased appliances at the residential address entered above. Used, rebuilt, or refurbished appliances do not qualify for this rebate.
- Rebates are given for installed appliances only (not for stub-outs).
- Propane industry employees are eligible for rebates.
- Grills **must be piped in** (no removable tanks/containers) and **must be sold by a propane dealer** licensed with the Florida Department of Agriculture and Consumer Services.
- Propane industry employees are eligible for rebates.
- Rebates must include **ITEMIZED** receipts for all appliances.
- A **SIGNED** work order stating appliance model number AND serial number **MUST BE SUBMITTED** with the rebate form.
- Rebate forms must be submitted 60 days from installation date on existing homes and 90 days from installation date for new homes.
- Rebate forms must be approved and signed off by a propane dealer licensed with the Florida Department of Agriculture and Consumer Services or their representative and must be installed per all local, state, and national codes.
- Rebate forms **MUST BE SUBMITTED** by a propane dealer licensed with the Florida Department of Agriculture and Consumer Services.
- Rebates are subject to change without notice and are only available while funds are available.
